Worldwide (Excluding CIS)

Caterpillar Inc. or any of its subsidiaries ("Caterpillar") warrants the following new products sold by it in regions other than the Commonwealth of Independent States ("CIS"), to be free from defects in material and workmanship:

- 16, 18 & 24 Motor Graders
- Attachments installed on such machines prior to delivery (unless covered by another Caterpillar warranty statement).

This warranty does not apply to:

- Cat Batteries
- Other models of motor graders
- Motor graders sold in the CIS

These products are covered by other Caterpillar warranties.

This warranty is subject to the following:

Warranty Period

The warranty period for power train components is 24 months or 10,000 hours whichever comes first starting from date of delivery to first user. For purposes of this warranty, "power train components" shall mean engine, transmission, torque converter, differential, drive shaft, transfer gear group, final drive, rear axle group, tandem; excluding radiator, hoses & lines; engine starter, alternator and compressors.

The warranty period for all other parts and components covered by this warranty is 12 months starting from date of delivery to first user.

Caterpillar Responsibilities

If a defect in material or workmanship is during the warranty period, Caterpillar will, during normal working hours and at a place of business of a Cat dealer or other source approved by Caterpillar:

Asphalt Compactor Oscillation Drum Warranty

WORLDWIDE

Caterpillar Inc, or any of its subsidiaries ("Caterpillar"), warrants designated new asphalt compactor oscillation drums sold by it, to be free from defects in material and workmanship that materially affect the use of such designated new asphalt compactor oscillation drums (a "defect").

This warranty is subject to the following:

Warranty Period

For asphalt compactor oscillation drums equipped with standard shell material, the warranty period is 48 months/4000 hours, starting from the date of delivery to the first user.

For asphalt compactor oscillation drums equipped with the optional hardened drum shell material, the warranty period is 84 months/7000 hours, starting from date of delivery to the first user.

Caterpillar Responsibilities

If a defect is found during the applicable warranty period, Caterpillar will, during normal working hours and at a place of business of a Cat® dealer or other source approved by Caterpillar:

- Provide an allowance toward the purchase of a new drum. The allowance will be based on drum wear at time of failure. Allowances will be calculated as follows:

$$\text{User Allowance} = \frac{(A - B) \cdot (C)}{D}$$

A – Average Measured Thickness of the Drum at Failure

B – Drum Thickness at 100% Worn *

C – Current Markup Price

D – Total Usable Drum Thickness (Drum Thickness at New* Minus Drum Thickness at 100% Worn*)

Warranty Period

For tools used solely in snow applications, the warranty period is 24 months starting from date of delivery or sale to the first user.

For bale (grab & spears), blades, buckets, compaction – wheels (mechanical), couplers – quick, fork carriages, grapples, material handling arms, and thumbs work tools sold in USA or Canada for and used solely on Mini Hydraulic Excavators, Skid Steer Loaders, or Compact Track and Multi Terrain Loaders, the warranty period is 24 months starting from date of delivery or sale to the first user.

For work tool line’s quick connect/disconnect components sold on serialized tools for mini hydraulic excavators, skid steer loaders, multi terrain loaders, and compact track loaders, the warranty period is 3 months starting from date of delivery or sale to the first user.

For SATCO branded Harvesting Heads and Felling Heads, the warranty period is 12 months / 2000 hours starting from date of delivery or sale to the first user.
